#### ELIGIBILITY:

I) The Candidate applying for any of the posts for which Teachers Eligibility Test is essential shall have acquired the following % and marks in Teachers Eligibility Test (CTET/TNTET/KTET/APTET) of the respective part (Part-I/II)
