It is informed that, the validity of the dongle in use for DSC authorization through Safenet tokens has ended on 30.06.2023. Further, e-Mudra has informed that the authorization of DSC related activities can be carried out only through the dongle containing the new version (compatible to the new Crypto Guidelines 2.0) from 01.07.2023 vide ref 1st cited.

Accordingly, the e-Mudra has also shared the guidelines (Q &A) for procuring the dongles with new version for Digital Signature Certificates (DSC) related activites.

In this regard, all TOs / PAOs / RJDs are instructed to follow the e-Mudra's guidelines annexed herewith to procure the DSC dongle (with new version).

# GUIDELINES FOR PROCURING & UPDATING BONGLES FOR DSC

#### 1. Will the current Tokens stop working from 01/07/2023?

Yes. As per the new guidelines all CAs should only download certificates in the USB hardware Tokens which serial number starts with OEM Prefix, for example, in HYP2003 Tokens the serial number should start with "HS", hence the certificate can't be downloaded in the existing tokens in circulation.

## 2. What happens to the Tokens on which DSC issued before 31/03/2023?

The tokens with DSC already issued on before 31/03/2023 will keep working until the entire validity of the DSCs on those.

### What happens if the user forgets the PIN or locks the token on which DSC is issued before 31/03/2023?

In case where user blocks the token by putting wrong PIN multiple times or forgets the user PIN, which means in the token blocking case, the user has to obtain DSC on new token as the exiting token with PIN blocked won't be able to download certificate on it after 31/03/2023 as per CCA guidelines.

- a) New Hype2003 tokens Serial no will start form HS
- b) WD Proxkey tokens Serial no will start form WD

# 6. How to identify the new HYP2003 tokens from the old one?

As seen in below picture, serial number for the new HYP2003 tokens, which are compatible to new guidelines, starts with "HS". Along with this, the serial number series of Token inside the middleware also starts from "HS". This can be checked inside the Token manager by plugging in the token.
