WHEREAS the Petitioners above named through their Advocate M/s. M. RAMGOPAL RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ Order or Orders, more in the nature of Writ of Mandamus declaring that declaring that Petitioners are eligible for promotion from the feeder category of Secondary Grade Teaches, who were appointed prior to 2010, are entitled to be promoted as School Assistants in their respective subjects like, Maths, Physics, Social, Biological Science, English, etc., basing on their seniority and eligibility without insisting for qualification of pass in Teacher Eligibility Test with all consequential benefits by holding the action of the respondents in insisting the petitioners to pass TET Test even who are appointed before 2010 is contrary to the instructions issued by the NCTE earlier and also contrary to the judgment of Allahabad High Court in Writ-A No.2879/2024, Writ-A No.9403/2023 and batch dt.19/03/2024 is clearly illegal, arbitrary, discriminatory and unjust and violative of Articles 14 and 16 of the Constitution of India.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents to consider the case of the petitioners for promotion as School Assistants who are appointed prior to 23/08/2010 as per the G.O.Ms.No.36 dt.23/12/2015 basing on their seniority and eligibility, without insisting for qualification of pass in Teachers Eligibility Test, pending disposal of WP.No.12410 of 2024, on the file of the High Court.

THE COURT MADE THE FOLLOWING ORDER:

Notice before admission.

Heard Sri M.Ramgopal Rao, learned counsel for petitioners and the learned Government Pleader for Services appearing on behalf of Respondents.

Learned counsel for petitioners submits that all the petitioners were appointed as Secondary Grade Teachers between 1995 and 1998 i.e. prior to the notification issued by NCTE on 23.8.2010 and therefore they are eligible and entitled to be promoted to the post of School Assistants in the relevant subjects. The learned counsel, by placing reliance on paragraph No.4 of Notification dated 23.8.2010 issued by NCTE, submits that the Teachers appointed prior to the date of this notification need not to acquire the minimum qualifications specified in the said notification. Therefore, petitioners who are appointed prior to the said notification are exempted from passing of Teacher Eligibility Test Examination to get promotion to the higher post as per G.O.Ms.No.36 School Education (Training) Department dated 23.12.2015 issued by respondents.

Learned Government Pleader, on instructions, submits that in a similar case i.e., W.P.No.26915 of 2023, dated 27.09.2023, this Court passed the following order:

"However, this Court finds that in this writ petition, the petitioner is challenging the principle adopted by the respondents in preparing the seniority list of all the candidates for promotion including the candidates, who did not possess the qualification as per NCTE regulation. The rules relied upon by the learned Government Pleader are of the year 2009, whereas NCTE regulations have come in the year 2010/2011. Therefore, NCTE guidelines are binding on the State and the State would have to follow the NCTE guidelines for preparing the seniority list.

In view of the same, the respondents are directed to affect the promotions to the post of School Assistant, strictly in accordance with NCTE regulations, pending further orders from this Court.

List this matter on 01.11.2023, for counter of respondents."

A perusal of G.O.Ms.No.36 School Education (Training) Department dated 23.12.2015, makes it clear that the Teachers who were appointed before NCTE notification dated 23.8.2010 are exempted from appearing for TET. The relevant paragraph No.12 of the said G.O. reads as under:

"EXEMPTION FROM PASSING TET:

Teachers who were appointed before NCTE notification dated 23.8.2010 by the Competent Authority in Government/Local Authority as per recruitment Rules prevalent at that time are exempted from appearing for TET. However, Teachers working in Private Schools whose appointments were not approved by the competent authority are not exempted from passing TET. Such Teachers of Private Unaided Schools shall appear for TET conducted by either the State Government or Central Government. In respect of non-approved Teachers working in Private Aided Schools, they shall invariably appear for TET conducted by the State Government only".

In a similar issue, the Division Bench of Allahabad High Court in W.A.No.2879 of 2024 and batch while extracting the following from the affidavit filed by NCTE;

"3. That NCTE in exercise of powers under Sub-section (1) of Section 23 of the RTE Act vide notification dated 23.08.2010 and 29.07.2011 has prescribed minimum qualification for appointment as teacher for classes 1 to 8. That vide these notifications passing the Teacher Eligibility Test conducted by the appropriate government in accordance with the guidelines framed by the NCTE is one of the criteria of becoming Teachers for classes 1 to 8. That the criteria for the purpose of promotion of the Assistant Teacher has also been prescribed by the NCTE in these notifications. A copy of these notifications 23.08.2010 and 29.07.2011 is being filed herewith and marked as Annexure-SCA-1 & 2 to this affidavit.

4. That the NCTE in exercise of the powers conferred under Clause (dd) of sub-section (2) of section 32 read with section 12A of the NCTE Act 1993 framed the National Council for Teacher Education (Determination of Minimum Qualification for Persons to be recruited as Education teachers and Physical Education teachers in Pre-primary, Primary, Upper Primary, Secondary, Senior Secondary or Intermediate Schools or Colleges) Regulations, 2014.

That rule 4(b) of the Regulations 2014 prescribed criteria for promotion which is quoted below –

- '4(b). For Promotion of teachers the relevant minimum qualifications as specified in the first and second schedule(s) are applicable for consideration from one level to the next level.'
- 5. That the Clause 3 of First Schedule of NCTE Regulations 2014 that minimum qualification as laid down by the NCTE Notification dated 23.08.2010 as time to time amended is applicable.
- 6. That clause 4 of NCTE Regulations dated 23.08.2010, states as follows:
- / Teacher Appointed before the date of this Notification: The following categories of teachers appointed for classes I to VIII prior to date of this Notification need not acquire the minimum qualifications specified in Para (1) above,:
- a. A teacher appointed on or after the-3rd September, 2001 i.e., the date on which the NCTE (Determination of Teachers in Schools) Regulations, 2001 (as amended from time to time) came into force, in accordance 'Withthat Regulation.
 - Provided that a teacher of class I to V possessing B.Ed qualification, or a teacher possessing B.Ed (Special Education) or D.Ed (Special Education) qualification shall undergo an NCTE recognized 6-month special programme on elementary on elementary education.
- b. A teacher of class 1to V with B.Ed qualification who has completed a 6month special Basic Teacher Course (Special BTC) approved by the NCTE.

- the prevalent Recruitment Rules"
 - clarified that (a) Appointees before notification dated 23.8.2010 does not mandatorily require to pass TET and their promotion be considered whether they have passed TET or not?
 - (b) So far as appointees subsequent to 23.8.2010 are concerned, their promotion shall be considered if they are passed TET Primary or TET Upper, as the case may be.
 - (c) Aforesaid exercise of promotion be concluded expeditiously, preferably within six months from today, if there is no legal impediment."

In view of the above, this Court is of the view that the petitioners have made out a prima facie case for grant of interim order. There is a force in the contention of the petitioners.

Therefore, the respondents are directed to consider the case of the petitioners for promotion to the post of School Assistants in their respective subjects without insisting for passing of Teacher Eligibility Test (TET) Examination, as and when promotions takes place.
