ORDER:

According to the existing orders, the High Schools under all kinds of managements with a pupils' strength of 1000 and above are eligible for appointment of Assistant Headmaster with the special pay of Rs 25/- p.m. In the case of Government School the question of appointment of Assistant Headmaster is considered on merit of each case even though the pupils strength in these schools is above 1000.

The Assistant Headmasters will continue to get the special pay of Rs. 25/- p.m. only so far as the pupils strength of the school continues to be more than 1000 and they will cease to get the special pay when the pupils strength of the school falls below 1000. In G.O. Ms. No. 1050, Finance (PC), dated 5.10.78 the Government have made provision for payment of a special pay of Rs. 25/-p.m. to Assistant Headmasters in High Schools with pupils strength of 750 or more as per the recommendations of the III Pay Commission. The Graduate Teachers Federation has also represented to Government for appointment of Assistant Headmasters in the High Schools.

2. The Government after careful consideration have decided that in the High Schools or in the Higher Secondary Schools (which includes High School Classes also) with a Pupil's STRENGTH.

- vi) When the pupil strength of the School falls below 750 there shall not be an Assistant Headmaster and the special pay paid to the senior most person as assistant Head Master will cease to be paid to him.
- 3. The Director of School Education is requested to implement the orders in para 2 above. The orders will take effect from the school year 1979 80.
- 4. This order issues with the concurrence of the Finance Department vide its U.O.No. 42230 B2/79-1, dated 9.4.79.

- 2. The G.O. should be communicated immediately to the heads of all High Schools and Higher Secondary Schools and managements of aided schools including Executive authorities of schools under local bodies and their acknowledgements obtained and filed.
- 3. For determining the eligibility of a school for an Assistant Head-master, the pupils strength as on 1st July of the year should be taken from the date of re-opening of the school depending upon eligibility and in any case this will take effect from 1st July 1979. The Assistant Head master will be eligible for a special pay of Rs. 25/- per mensem.
- 4. The inter-seniority among the eligible members of the staff of the school for the purposes of designating the senior most as Assistant Headmaster, will be determined by the date of first appointment to the B.T., scale of pay. However in the case of Post Graduate Teachers in Higher Secondary Schools recruited direct, the date of appointment as Higher Secondary Teachers will be taken into account. It should be carefully noted that the G.O. makes all categories of Teachers I Pandits and Physical Directors drawing B.T., scale of pay will come under this category. The Assistant Headmasters post now given will go to the senior most person in this category and if will automatically as this is being governed by a separate set of rules.

- 5. If any of the schools are already having an Assistant Headmaster, the present incumbent can be allowed to continue as Assistant Head-master only if the school is having a strength of 750 and above and the present incumbent is eligible to hold the post on grounds of seniority.
- 6. THE ASSISTANT HEADMASTER SHOULD BE ALLOTTED ONLY 10 CLOCK HOURS OF TEACHING WORK PER WEEK SO AS TO ENABLE HIM TO DEVOTE THE REST OF THE HOURS FOR

attending to items of other work delegated to the Assistant Headmaster by the Headmaster. The Assistant Headmaster should assist the Headmaster in organizing and supervision Co-curricular and Extra-curricular activities in Stds. 6 to 10 as suggested by the Headmaster.

THE CHECKING OF NOTES OF LESSONS, AND SUPERVISION OF TEACHING ETC WILL CONTINUE TO BE DONE BY THE HEADMASTER HIMSELF.

- 7. Each District. Edl. Officer / Inspectress of Girls Schools will furnish by 14.7.79 a list of High Schools / Higher Secondary Schools in his/her jurisdiction arranged management wise, which are eligible for the Assistant Headmasters, indicating against the name of each standard functioning in the school and the total strength of pupils in all the standards as on the 1st July 1979.
- 8. They should also send a list of schools previously having Assistant Headmaster but became ineligible for it during 79-80 due to fall in strength etc.,
- 9. The names of Higher Secondary Schools ineligible for the Assistant Headmaster, if any, should also be reported for record in this office.
- 10. The District Educational Officers and Inspectresses of Girls Schools should watchful, review the students strength as on 1st AUGUST 1979 in every High School / Higher Secondary School and issue orders (not in piece meal) declaring the names of schools eligible for Assistant Headmaster for the academic year 79-80, before 15.7.79. Copies of such order should invariably be endorsed to the Chief Edl., Officers and the Director.
- 11. The receipt of these proceedings should be acknowledged at once and this should be communicated to all High and Higher Secondary Schools within 3 days. This is most immediate.

In connection with the appointment of Assistant Headmaster in High and Higher Secondary Schools, certain clarifications have been sought for by inspecting Officers and the following clarifications are issued:

i) The Assistant Headmaster allowed by Government in G.O. Ms. No. 887, Edn., dated 5.6.79 is to look after academic work of the school and to relieve the Headmaster of his heavy responsibilities. It does not involve employment of an outsider. Senior most of the existing staff members of the eligible categories will be named as

Assistant Headmaster. As such, the questions of management having its choice in the matter of designating the Assistant Headmaster does not arise at all. After all, it the matter of designating the Assistant Headmaster who will have to be designated is one of the employees of the management who will have to be designated is one of the employees of the management, making invidious distinction among its experience is no separate post of Assistant Headmaster. Hence the students in all the standards of a High School/Higher Secondary School should be reckoned for determining the eligibility of a school for an Assistant Headmaster.
- iii) Since the service records of the staff members of Government school are maintained by the Heads of institutions themselves, they will be in a better position to determine the inter seniority of the members of the school in the eligible categories for designating one as Assistant Headmaster concerned will issue an order regarding designation of Assistant Headmaster and circulate it among the staff members designation of Assistant Headmaster and circulate it among the staff members besides extending a copy of it to the District Educational officer concerned. If there is any representation against the order, it may be disposed of by the DEO concerned after going through the connected records. If necessary, the appointing authority concerned may be consulted, before passing orders on such representation.

In the case of Aided schools also the correspondents in consultation with the Headmaster will take action for designating the Asst. Head Master, be it in a High School or Higher Secondary School. They should see that there should be no deviation. After designating the person as Asst. Headmaster they should inform the Inspecting Officer concerned. In the case of Aided Schools for determining the seniority service under that management alone will have to be taken in to account

In the case of Local Body Schools, executive authority concerned should be required to report the names of teachers designated as Asst. Headmasters in the Schools declared eligible for it and furnish a certificate to the effect that only those eligible as per G.O. have been designated as Asst. Headmasters.

 - 4. The above order will apply to Higher Secondary Schools under all kinds of managements.
- 5. The Assistant Headmaster (Higher Secondary) will be incharge of the school during the period of absence of the Headmaster, while proceeding on Casual Leave / Short term leave or while attending conference /seminars etc.

- 2. The Government have received representation with a request to give benefit of this post of Assistant Headmaster to the other category of Teachers working in the secondary grade scale of pay viz. Physical Education Teachers, Drawing Master, Craft Teachers etc., along with the Secondary Grade Teacher. The Director of School Education who was consulted in the matter has recommended this request.
- 3. The Government have considered this request and have now decided to extend this benefit to the Teachers working in the Secondary Grade scale of pay. Accordingly in continuation of G.O. Ms. No. 469, Education, dated 25.3.88 the Government direct, that the Teachers working in the Secondary Grade scale of pay like Physical Education Teachers, Drawing Masters, and craft Teachers etc., in all High and Higher Secondary Schools with a pupil strength of 750 and above, be considered along with the standard 6 to 8 only.
