Orders:-

The Special Rules for the Tamilnadu Adi Dravidar Welfare Subordinate Service have been issued in the Government order first read above for the post of BT Assistants, Secondary Grade Teachers, Pandits and Head Master of High Schools Working in Adi Dravidar Welfare among other posts.

2. In the letter 2nd and 3rd read above, the Director, Adi Dravidar Welfare and Director, Tribal Welfare have proposed to amend the Special Rules for Adi Dravidar Welfare Subordinate Service by adding a new entries called unit of appointment for the posts classified in Class I in section 18 of Tamilnadu Adi Dravidar Welfare Subordinate Service Rule, as follows:-

Unit of Appointment:- For the purpose of appointment to the Categories 2, 3, 4 & 6 of Class I in this service the State shall be the unit of appointment.

3. After careful consideration, the Government have decided to accept the proposals of Directors of Adi Dravidar and Tribal Welfare and to issue the following amendment to the Special Rules for the Tamilnadu Adi Dravidar Welfare Subordinate Service to make the State as the unit of appointment in respect of the Categories 2, 3, 4 & 6 of Class I in the said Service. Accordingly, the Director, Adi Dravidar Welfare and Director, Tribal Welfare are directed to prepare a Statewide seniority list respectively of the persons holding in respect

of said categories based on the date of their regular appointment as on 01.03.2024. It is also directed that while preparing such Statewide seniority lists, none of the regular incumbents of the aforesaid categories as on 01.03.2024 shall be reverted to the lower post.

4. The following notification shall be published in Tamil Nadu Government Extraordinary Gazettee:-
