ORDER:-

In Government Order third read above, 202 Special B.Ed., Graduate Teachers posts were created for implementation of Inclusive Education for Disabled at Secondary Stage (IEDSS) scheme to impart special education to the differently abled children studying in Government High and Higher Secondary Schools and the Director of School Education was instructed to take action to frame Adhoc Rules as there are no service rules for the post of special B.Ed., Graduate Teacher. In the letter fifth read above, the Director of School Education has sent the proposal to Government and requested to frame the Adhoc Rules. In the National Council for Teacher Education Notification F.No.61-03/20/2010/NCTE/(N&S), dated 23.08.2010 which prescribes for minimum qualifications for a person to be eligible for appointment as a teacher in Class I to VIII in a School. Para 2 of the said notification provides that in case of Diploma in Education

(Special Education) and B.Ed., (Special Education), a course recognized by the Rehabilitation Council of India (RCI) only shall be considered. The Rehabilitation Council of India vide its Notification No.7-91/RCI-2011, dated 11.01.2012 had issued guidelines for minimum requirement of Rehabilitation Council of India approved qualification for appointment of Special Education Teachers. The Government after careful examination has accepted the proposal of the Director of School Education and accordingly framed Adhoc Rules for the said posts.

The following notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:-

2. The rules hereby made shall be deemed to have come into force on and from 30.01.2015.

RULES

The Tamil Nadu Government Servants (Conditions of Service) Act 2016 and the Special Rules applicable to the holders of the permanent posts of Graduate Teacher (Subject) in Class I, category 2 of the Tamil Nadu School Educational Subordinate Service shall apply to the holders of the temporary post of Graduate Teacher (IEDSS) in School Education Department, subject to the modifications specified in the following rules :-

2. Constitution.-The post shall constitute a separate category in distinct class of the said service.

3. Appointing Authority.- The appointing authority for the post shall be the Joint Director of School Education (Personnel)

4. Qualification.- (a) Age.- Notwithstanding anything contained in sub-section (8) of section 20 of the Tamil Nadu Government Servants (Conditions of Services) Act 2016, no person shall be eligible for appointment by direct recruitment if he/she has completed 53 years for General category and 58 years for others

(b) Other Qualification .- No person shall be eligible for appointment to the post unless he/she possesses the following qualifications namely:-

Graduate with,

- (i) B.Ed. (Special Education); or
- (ii) B.Ed. (General) with one year Diploma in Special Education; or
- (iii) B.Ed. (General) with two years Diploma in Special Education; or
- (iv) B.Ed. (General) with Post Graduate Professional Diploma in Special Education (PGPD); or
- (v) B.Ed. Special Education and Post Graduate Professional Certificate in Special Education (PGPC); or
- (vi) PG Diploma in Special Education (Mental Retardation); or
- (vii) PG Diploma in Special Education (Multiple Disability: Physical &

- Neurological); or
- (viii) PG Diploma in Special Education (Locomotor Impairment and Cerebral Palsy); or
 - (ix) Secondary level Teacher Training Course in Visual Impairment; or
 - (x) Senior Diploma in Teaching the Deaf; or
 - (xi) B.A. B.Ed. in Visual Impairment; or
 - (xii) B.A./B.Lit., degree in Tamil or its equivalent from recognized University with B.Ed., degree in Special Education from recognized University with specialisation in VI (Visual impairment) / HI (Hearing Impairment)/ MR (Mental Retardation) for B.T. Assistant (Tamil) (IEDSS);

and

Must have passed in Teacher Eligibility Test Paper-II:

Provided that a person with B.Ed., (Special Education) degree must be with Specialization in VI (Visual impairment) / HI (Hearing Impairment)/ MR (Mental Retardation).

5. Savings.- Nothing contained in these rules shall adversely affect the person appointed to the post prior to the date of publication of the rules in the Tamil Nadu Government Gazette.


